TECHNICAL SESSION

Speaker—Tom Wierman—COPAS Executive Director

Tom Wierman has been the COPAS Executive Director since March, 2012. Prior to that, Tom worked as an E&P accountant for nearly 30 years. Tom held assignments in Wichita, São Paulo, Rio de Janeiro (Brazil) and Calgary Alberta (Canada).

Tom has served as a society president and a board member for both the Kansas and Canada societies. At the COPAS level, he served as Tax Committee Chair, and was a board member for six years. In 2009 he served as COPAS president. Tom was also a major contributor on the 50th Anniversary of COPAS special committee, a successful event during the April 2011 meeting in Houston. He was awarded the COPAS *Eagle Award* in 2013.



Tom has been married for 24 years to Paula. They have three children, Chris (22), a Senior at the University of Oklahoma, Molly (19) a

Speaker—Don Tharp—COPAS Director of Training & Education

Hello, everyone! The last meeting of the COPAS OKC Joint Interest and Audit Committees was on 10/16/14. The JI Committee had 31 people representing 9 companies, and the Audit Committee had 36 people representing 8 companies. The Audit Committee voted on 1 document and 2 charter updates. The Rig-Related Costs document passed by a vote of 6-1. The update to the Audit Committee charter passed by a vote of 7-0, and the update to the Emerging Issues Subcommittee charter passed by a vote of 7-0.

The JI Committee also voted on the Rig-Related Costs document and it passed 4-0. They also voted on updates to the JI Committee Charter, Benefits Subcommittee Charter, and Materials Subcommittee Charter, and all three updates passed 5-0. JI also voted on the benefits limitation percentage of 33% (passed 5-0), and the process change for calculating the employee benefits 2016 limitation (passed 5-0).

The last meeting was very busy. The JI and Audit Committees will not be meeting before the December Holiday Luncheon. We hope to see you at the Luncheon! Hope your Holidays have been great!
